



# The Municipal Corporation of the Town of Fort Erie

## By-law No. 82-2017

---

### Being a By-law to Appoint Members of Council as Chair and Vice-Chair for Each Business Subdivision of Council and to Repeal By-law No. 41-2016

---

**Whereas** Council Rules of Procedure By-law No. 36-2016 was passed by Council on March 29, 2016 to adopt Council Rules of Procedure; and

**Whereas** Section 18.8 (b) of By-law No. 36-2016 provides that prior to August 1 in the third year of the term, Council meets in open session and selects the Chair and Vice-Chair for each Business Subdivision for the last sixteen month period of the term and that a Chair and Vice-Chair may be returned to the same post; and

**Whereas** Section 18.8 (c) of By-law No. 36-2016 provides that at the eight month mark of each of the three sixteen month periods of the term, the Chair and Vice-Chair shall switch positions within each Business Subdivision; and

**Whereas** By-law No. 41-2016 was passed by Council on March 29, 2016 to Appoint Members of Council as Chair and Vice-Chair for each Business Subdivision of Council; and

**Whereas** it is necessary to appoint Members of Council as Chair and Vice-Chair for each Business Subdivision of Council for the period August 1, 2017 to November 30, 2018 and to repeal By-law No. 41-2016;

**Now therefore** the Council of the Town of Fort Erie enacts as follows:

1. **That** the following Councillors are appointed as Chair and Vice-Chair of the respective Business Subdivisions for the period of August 1, 2017 to November 30, 2018:

- a. **Corporate and Community Services**

Chair                      Councillor Knutt

Vice-Chair      Councillor McDermott

- b. **Planning and Development Services**

Chair                      Councillor Passero

Vice-Chair      Councillor Lubberts

**c. Infrastructure Services**

Chair            Councillor Zanko

Vice-Chair    Councillor Butler

**2. That** By-law No. 41-2016 is repealed.

**3. That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

**Read a first, second and third time and finally passed this 17<sup>th</sup> day of July, 2017.**
