## By-law No. 115-2017

---

### Being a By-law to Amend Traffic By-law No. 2000-89 All-Way Stop at Intersection of Ridge Road South and Farr Avenue and Reduction of Speed Limits on Sections of Holloway Bay Road, Nigh Road and Townline Road

---

**Whereas** By-law No. 2000-89, as amended, provides for the regulation of traffic and parking on highways in the Town of Fort Erie; and

**Whereas** Report No. IS-30-2017 was considered at the Council-in-Committee Meeting held on October 2, 2017 and subsequently authorized and approved by Council, to amend Schedule "N" of By-law No. 2000-89 to establish an all-way stop at the intersection of Ridge Road South and Farr Avenue; and

**Whereas** Report No. IS-31-2017 was considered at the Council-in-Committee Meeting held on October 2, 2017 and subsequently authorized and approved by Council, to amend Schedule "U" of By-law No. 2000-89 to reduce speed limits along portions of Holloway Bay Road, Nigh Road and Townline Road; and

**Whereas** it is deemed desirable to amend Traffic By-law No. 2000-89, as amended, accordingly;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** Schedule "N" to By-law No. 2000-89, as amended, is further amended by inserting the following:

2. **That** Schedule "U" to By-law No. 2000-89, as amended, is further amended by inserting the following:

SCHEDULE "U"		
SPEED LIMIT ON HIGHWAYS		
COLUMN 1	COLUMN 2	COLUMN 3
STREET	BETWEEN	RATE OF SPEED
Holloway Bay Road	South limit of Michener Road to the south limit of Marcy's Lane	50 kph
Nigh Road	West limit of Cauthard Road to the intersection at Highway #3	70 kph
Townline Road	East limit of Switch Road to the intersection at Niagara Parkway	70 kph

3. **That** the installation of additional 50 kph speed limit signs on Nigh Road between Cauthard Road and Gorham Road, one in each direction, be erected.
4. **That** this by-law shall be enforceable upon the installation of the appropriate signage as required for each of the above amendments.
5. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
