

## The Municipal Corporation of the Town of Fort Erie

By-law No. 115-2017

Being a By-law to Amend Traffic By-law No. 2000-89
All-Way Stop at Intersection of Ridge Road South
and Farr Avenue and
Reduction of Speed Limits on Sections of
Holloway Bay Road, Nigh Road and Townline Road

**Whereas** By-law No. 2000-89, as amended, provides for the regulation of traffic and parking on highways in the Town of Fort Erie; and

**Whereas** Report No. IS-30-2017 was considered at the Council-in-Committee Meeting held on October 2, 2017 and subsequently authorized and approved by Council, to amend Schedule "N" of By-law No. 2000-89 to establish an all-way stop at the intersection of Ridge Road South and Farr Avenue; and

**Whereas** Report No. IS-31-2017 was considered at the Council-in-Committee Meeting held on October 2, 2017 and subsequently authorized and approved by Council, to amend Schedule "U" of By-law No. 2000-89 to reduce speed limits along portions of Holloway Bay Road, Nigh Road and Townline Road; and

Whereas it is deemed desirable to amend Traffic By-law No. 2000-89, as amended, accordingly;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

**1. That** Schedule "N" to By-law No. 2000-89, as amended, is further amended by inserting the following:

**2. That** Schedule "U" to By-law No. 2000-89, as amended, is further amended by inserting the following:

- **That** the installation of additional 50 kph speed limit signs on Nigh Road between Cauthard Road and Gorham Road, one in each direction, be erected.
- **4. That** this by-law shall be enforceable upon the installation of the appropriate signage as required for each of the above amendments.
- **5. That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
