

The Municipal Corporation of the Town of Fort Erie

By-law No. 119-2019

Being a By-law to Authorize the Entry into an Operating Agreement with Don Fulton O/A Don Fulton and Sons Special Sports Enterprises for Food Concession Services at the Crystal Ridge Arena

Whereas pursuant to By-law No. 85-96, The Corporation of the Town of Fort Erie entered into an Agreement with Don Fulton O/A Don Fulton and Sons Special Sports Enterprises for the provision of food concession services at the Crystal Ridge Arena, for a period of 10 years with an option to extend the Agreement for a further 10 years; and

Whereas By-law No. 126-09 passed September 28th, 2009 by the Municipal Council of the Town of Fort Erie authorized the Mayor and Clerk to execute an Operating Agreement with Don Fulton O/A Don Fulton and Sons Special Sports Enterprises for the provision of food concession services at the Crystal Ridge Arena for a further 10 year period commencing October 1, 2009; and

Whereas Report No. IS-19-2019 was considered and approved at the Council-in-Committee Meeting held on June 10, 2019 to authorize the entry into a new Operating Agreement for food concession services at the Crystal Ridge Arena with Don Fulton O/A Don Fulton and Sons Special Sports Enterprises for a 10 year period commencing on October 1, 2019 with an option to extend the agreement for a further 10 years; and

Whereas it is deemed desirable to enter into a new Operating Agreement with Don Fulton O/A Don Fulton and Sons Special Sports Enterprises for a 10 year period commencing on October 1, 2019 with an option to extend the Agreement for a further 10 years;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- 1. That the entry into an Operating Agreement with Don Fulton O/A Don Fulton and Sons Special Sports Enterprises for a 10 year period commencing on October 1, 2019 with an option to extend the agreement for a further 10 years, and in a form acceptable to the Town Solicitor, is authorized and approved.
- **2. That** the Mayor and Clerk are authorized and directed to execute the said Operating Agreement and affix the corporate seal thereto.

3. That the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 26th day of August, 2019.
