By-law No. 128-2019

Being a By-law to Authorize the Execution of A Site Plan Agreement With 2552078 Ontario Ltd. (Xue Hu Huang) (2043 Garrison Road, Fort Erie)

Whereas Report No. PDS-50-2019 was considered and approved, as amended, at the Council-in-Committee meeting of September 9, 2019 to authorize the entry into a Site Plan Agreement for 2043 Garrison Road with 2552078 Ontario Ltd.; and

Whereas the Municipal Council of the Town of Fort Erie at its meeting of June 21, 2004 passed Resolution No. 25 to establish a practice whereby the Standard Form of Agreement would not be attached to the By-law and circulated to each Member of Council in advance of the particular Council Meeting, although Council has been informed under Report No. PDS-50-2019 of the Financial Schedule in the Agreement, with the knowledge that the Clerk of the Town of Fort Erie is in possession of the full Agreement at the subject Council Meeting, and

Whereas it is deemed desirable to enter into a Site Plan Agreement for 2043 Garrison Road (South side of Garrison Road, west of Laur Road) with 2552078 Ontario Ltd. in order to control the development of the lands described in Schedule "A" of the Site Plan Agreement attached hereto as Appendix "1" and forming part of this by-law;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** the entry into a Site Plan Agreement with 2552078 Ontario Ltd. (the "Developer"), substantially in the form attached as Appendix "1" and forming part of this by-law, is authorized and approved, subject to the Developer first satisfying the provisions of the Agreement which are required to be satisfied prior to execution of the Agreement.
2. **That** subject to Section 1 of this by-law, the Mayor and Clerk are authorized and directed to execute the said Site Plan Agreement and affix the corporate seal thereto, and all other documentation necessary to effect the terms and conditions of the said Agreement.
3. **That** this by-law shall expire one (1) year from the date of passage should 2552078 Ontario Ltd. fail to enter into the Site Plan Agreement with the Town.

4. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections, or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 23rd day of September, 2019 .
