



The Municipal Corporation of the Town of Fort Erie

By-law No. 80-2020

Being a By-law to Rename an Untraveled Road from Clarkson Crescent to Beachwalk Crescent and to Rename an Untraveled Road from Clarkson Court to Loganberry Court

WHEREAS the Street Naming and Wayfinding Committee at its meeting of December 10, 2019 recommended the renaming of an untraveled road from Clarkson Crescent to Beachwalk Crescent and the renaming of an untraveled road from Clarkson Court to Loganberry Court; and

WHEREAS at the February 18, 2020 Regular Council Meeting, Council considered and approved the Street Naming and Wayfinding Committee's recommendations contained in the Street Naming and Wayfinding Committee's Minutes of December 10, 2019 to rename an untraveled road from Clarkson Crescent to Beachwalk Crescent and to rename an untraveled road from Clarkson Court to Loganberry Court; and

WHEREAS pursuant to the requirements of Street Naming Policy By-law No. 15-04 notice of the proposed street renamings was published in The Post for two consecutive weeks on August 13th and 20th, 2020, and posted on the Town's website; and

WHEREAS no objections were received to the proposed street renamings; and

WHEREAS it is deemed desirable to proceed to rename an untraveled road from Clarkson Crescent to Beachwalk Crescent and to rename an untraveled road from Clarkson Court to Loganberry Court;

Now therefore the Municipal Council of the Town of Fort Erie enacts as follows:

1. **That** an untraveled road known as Clarkson Crescent, legally described as PCL Streets-1, Sec M65; Clarkson Crescent, Plan M65; Fort Erie, being all of PIN 64184-0254 (LT), in the Town of Fort Erie, in the Regional Municipality of Niagara, is renamed "Beachwalk Crescent".
2. **That** an untraveled road known as Clarkson Court, legally described as PCL Streets-1, Sec M65; Clarkson Court, Plan M65; Fort Erie, being all of PIN 64184-0253 (LT), in the Town of Fort Erie, in the Regional Municipality of Niagara, is renamed "Loganberry Court".

3. **That** the Town Law Clerk shall cause this by-law to be registered in the local land Registry Office.
4. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 24th day of August, 2020.
