



# The Municipal Corporation of the Town of Fort Erie

## By-law No. 54-2022

---

### Being a By-law to Appoint Troy Davidson as Drainage Superintendent for The Corporation of the Town of Fort Erie (and Repeal By-law No. 87-2014)

---

**Whereas** Section 93 of the *Drainage Act*, R.S.O. 1990, c. D.17 provides that the council of a local municipality may by by-law appoint a drainage superintendent who shall:

- a) inspect every drainage works for which the municipality is responsible and report periodically to council on the condition of those drainage works;
- b) initiate and supervise the maintenance and repair of the drainage works for which the municipality is responsible;
- c) assist in the construction or improvement of the drainage works for which the municipality is responsible; and
- d) report to council on the superintendent's activities mentioned in clauses (b) and (c); and

that the council may provide for fees or other remuneration for services performed by drainage superintendents in carrying out their duties under this *Act*, but the fees or other remuneration shall not be deemed to form part of the cost of the drainage works and shall be paid from the general funds of the municipality; and

**Whereas** By-law No. 87-2014 was passed by the Municipal Council of the Town of Fort Erie on the 16<sup>th</sup> day of June, 2014 to appoint David Maiden as Drainage Superintendent for The Corporation of the Town of Fort Erie (the "Town"); and

**Whereas** David Maiden has retired from his employment with the Town, and Troy Davidson is the successful applicant to fill the role of Drainage Superintendent for Town; and

**Whereas** it is deemed desirable to appoint David Maiden as Drainage Superintendent for the Town;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** Troy Davidson is appointed Drainage Superintendent for The Corporation of the Town of Fort Erie and he shall perform the duties and exercise the powers of Drainage Superintendent in accordance with the provisions of the *Drainage Act*, R.S.O. 1990, c. D.17.
2. **That** By-law No. 87-2014 is repealed.

- 3. That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

**Read a first, second and third time and finally passed this 30<sup>th</sup> day of May, 2022.**
