



TOWN OF FORT ERIE DEVELOPMENT CHARGES

By-law No. 20-2024, 21-2024, and 22-2024 establishes development charges for new development and redevelopment within the Town. The revenue generated by the development charge ensures that growth related infrastructure can be funded without affecting the Town's existing tax base while meeting growth needs.
