Resident believes there is a blockage between the clean-out and the storm main.	Review of the as-built drawings shows that the storm lateral was decommissioned in 2007. Resident may not have noticed a problem with the storm lateral if it was open ended and draining into the road subgrade. Sump pump and roof leaders are currently running into the plugged storm lateral. Staff explained that there can be no direct connections to the storm lateral for these items and they have to discharge overland. A catch basin can be installed at property line to help collect this water run-off.

2023-04-17	344 Scott Rd	Concerned about the high level of water in the storm sewer on the property. It was much higher than normal and this was before the storm and it had not rained in a while.	Staff have investigated and have the catch basin scheduled for flushing.
